NOTICE TO PETITIONERS

For prompt and assured consideration, return this petition to the issuing office shown below within one year of issuance with valid signatures from owners of over 50% of the area. If the petition is in order, it will be sent to the City Council, which may grant or deny it.

If this improvement is authorized by the City Council, the owners of all property to be assessed will be sent a notice of the date set for public hearing of protests. To receive such notice, names of the owners of the property must appear on the ownership records of the City Clerk, 201 North Figueroa Street, Room 730, Los Angeles, CA 90012.

The cost of improvements ordered by the City Council will be assessed upon all the properties in proportion to the benefits received from the improvements.
